## Plan Summary [LCAP Year]

### General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

YouthBuild Charter School of California holds a unique place in the landscape of California’s public charter schools. Its mission is to provide a high school education that leads to a diploma for a distinct group of students. All YCSC students come from low-income families and underserved communities and have previously left or been pushed out of the traditional school system without a diploma and have made their way to one of the many YouthBuild programs in the Southern California area. They enroll in the YouthBuild program over-aged, under-credited, or both, in order to receive vocational training, counseling, leadership development and an education. The students are between 16-24 years old, yet they are allowed to re-enroll in the K-12 school because they are a member of a YouthBuild program. The California Department of Education allows for this through an exemption that is written into California Education Code. In order to meet the unique needs of its students, YCSC has developed a project-based, interdisciplinary curriculum model that relies on authentic assessments and applied learning that provides numerous opportunities to connect a standards-based education to program activities at the YouthBuild program that are geared towards creating social justice in the communities where its students live.

The YouthBuild Charter School of California (YCSC) is a competency-based, dropout recovery high school that is designed to provide a supportive and challenging academic program for students who have not done well in traditional school settings. YCSC opened its doors in September, 2008 to 265 students, at three YouthBuild program sites in Los Angeles County. The School was launched and continues to be supported by the

national organization YouthBuild USA in response to California YouthBuild programs' need for a robust high school diploma based education option for their students. YCSC currently utilizes an internally developed the Authentic and Collaborative Education (ACE) Interdisciplinary Learning and Program Integration (ILPI) Manual and its assessment competencies (Humanities, STEM, Culture) in congruence with a prioritized set of the California State Standards, the Common Core Standards, and the Next Generation Science Standards.

The mission of the YouthBuild Charter School of California (YCSC) is to offer low-income, unemployed and undereducated youth ages 16-24 who have previously dropped out or aged out of high school a unique education program that successfully prepares them for a high school diploma and strengthens their skills to be transformative change agents while simultaneously preparing them for careers, postsecondary education, and life. The School's overarching goal is to use innovative, learning methods to challenge students to meet high expectations and rigorous standards and to prepare them to live meaningful lives as active, educated, engaged, self-sufficient adults who are responsible for themselves, their families and communities. In order to prepare young people for college and the technological and knowledge demands of the workplace, YCSC combines a rigorous, standards-based, academic curriculum emphasizing a project-based instructional model that prepares youth lead their communities for social change while each YouthBuild Site also provides a variety of different vocational training opportunities for careers in fields like nursing and information technology, in addition to industry-recognized certifications in construction. The School's focus on career skill building is supplemented by a hands-on curriculum in leadership and community development. Students prepare for community leadership through an innovative curriculum focused on the social and cultural history of the local community and critical awareness of important global issues. Students earn credits as they contribute to the community by building affordable new housing or refurbishing existing housing for local low income communities at worksite "construction labs." YCSC believes that, in addition to the skills required for success in postsecondary education and employment, and as contributing citizens in their communities, an educated person in the 21st century needs well-developed emotional intelligence skills such as self-reflection and self-concept, relationship-building, conflict resolution and work culture fluency. These skills are taught explicitly at YCSC in a rigorous, standards based curriculum and are reinforced by students' experiences in team projects, leadership development opportunities and in on-site vocational and life skills training.

YCSC participates in the CA School Dashboard via the Dashboard Alternative Schools Status option. YCSC focuses on supporting all populations with academic and emotional growth. YCSC has continued to obtain student and stakeholder survey feedback that significantly shows how much students feel that YCSC is a transformative experience for their lives. Based on local data YCSC has demonstrated a growth in enrollment and average daily attendance. Both have increased by over one hundred students this year. Given the availability of CCSSP pilot funds in the 22/23 school year, YCSC was able to streamline goal-setting for 23/24 utilizing the needs assessment data from both LCAP surveys and CCSSP surveying. This allowed for YCSC leadership to develop LCAP goals that had many similarities and parallels to CCSSP goals. In addition, the latter goals will also be informing the Community Action Project themes for 23/24.

## LCAP Highlights

YCSC has achieved success in all LCAP goals from last year. Student engagement & postsecondary readiness have been a central focus throughout the school year. Dedicated funds for activities have allowed all sites access to PSE and extracurricular field trips. To date most sites have accessed these funds to take one or multiple field trips. Sites have additional trips planned through June 2023. Staff have participated in a range of professional development including training from High Tech High. YCSC continues to focus on including Vocational Education & CTE into CAPs & APTs.

Quarterly staff development sessions for the 22-23 school year demonstrated commitment to existing and new educational resources. Three school wide professional developments occurred in August, January and March. In addition, monthly training and professional developments were available virtually. Staff also had the opportunity to seek out individual professional development that focused on personal growth areas aligned with YCSC LCAP goals. Technology has continued to play a key role in enhancing project-based learning. In addition, this has ensured students can access materials when they are unable to attend school.

YCSC is almost done spending its CSI funds since. The plans continue as follows: As per the **Stakeholder** input from annual LCAP surveying and as per the results of YCSC's Plan, Do Study, Act **Needs Assessment** conducted by 1 staff member per site, YCSC is using its CSI funds for the professional development of its leadership team, department chairs, and other staff tasked with improving the grad rate at YCSC. All staff provided with training funded by CSI funds will regularly share all knowledge with staff at quarterly YCSC professional development. The **Evidence-based interventions** focused on improving grad rate such as increased classroom accommodations, targeted counseling support, and the intentional scaffolding via YCSC interdisciplinary project based model have all come from continuing to provide professional development to YCSC staff.

tively review the 2-year grad rate data published by the CDE as its ultimate a measure of effectiveness for CSI grad rate improvement plans. Note: YCSC had previously achieved a grad rate above the 67% in 18/19 but the calculation for 19/20 was suspended by the CDE due to Covid-19.

Now that the CDE has calculated the metric again, YCSC is proud to be coming out CSI status but will continue focused on maintaining a grad rate above 70%.

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
